Para 1.20	Group meetings were held in Spring and Autumn at St. Lawrence's Church Hall, York, with various speakers, subjects and excellent food and refreshments. A visit was also organised in June to the Pocklington Canal, with a short boat trip. Activities contributing to the Group's funds have included: - • Sales of donated books and magazines and memorabilia, cameras, volunteers' badges and buttons, bringing in a total of £585.59. • Sale of new books and DVDs, Moorsline binders and sales proceeds from Group Meetings, St. Crux and our Model Railway Exhibitions, bringing in a total of £2,093.11.

The Group's volunteers have participated in crewing of trains, plus maintenance and repairs of the NYMR's permanent way, including the continual task of checking and oiling of fishplates along the whole of the line. Assistance with tracklaying was undertaken at Farworth and between there and Kingthorpe, at Goathland Bridges 24/25/27 and at Grosmont Shed. Group funds and volunteers' efforts have also been expended on repairs and overhauls to the
Civil Engineer's wagon fleet and on-track machines, including Weltrol E230908, Plate Wagons B932267 & B934286, Lowmacs B904152 & B905100, Borail B946060, Plasser 12T Crane 81312, Tampers 73250 & 23309 and our Ballast Regulator; also numerous other sundry parts, materials, paint and tools. We have also financed the aqcuisition of Lineside Tools and Storage for the NYMR's Lineside Conservation Officer. At the Derwent Valley Light Railway, the extensive restoration and overhaul of our former War Department Drewry diesel shunter was begun
with impressive progress achieved. Also engine and carburettor repairs were undertaken on the elderly JAP engine in our Wickham Trolley.
